

Primary Objective

Assist the Team Leader Playgrounds and Reactive Team lead the work team in the installation, maintenance and repairs of equipment in line with Australian standards, plus general horticultural activities at Council parks, ovals and associated facilities.

Key Responsibilities

- Assist with the planning, co-ordinating, supervision and on-the-job training of the Playgrounds and Reactive Team.
- Under limited direction carry out installation, maintenance and repair work on Council equipment including paving and fencing.
- Identify, remove weeds, pests and diseases and eradicate them through the use of pesticides and herbicides.
- Undertake a range of horticultural activities particularly mowing, spraying, slashing, top-dressing, scarifying, fertilising and aerating turfed areas.
- Operate and maintain a broad range of plant and equipment to a safe and competent standard and identify and report the need for necessary repairs.
- Work unsupervised and follow instructions.
- Write and interpret reports and work plans of moderate complexity.
- Keep accurate daily work records and report any issues including necessary repairs to the team leader in a timely manner.
- Work safely as part of a team following Council policies and procedures.
- Behave according to Council's Code of Conduct, including treating other employees and the general public with respect.
- Maintain own health and safety and that of other people in the workplace or those who may be affected by the work being carried out.
- Perform other Parks and Gardens support duties within capabilities and/or consistent with the level of this position as required.
