Primary Objective

Working in Playgrounds and Reactive Team, within Municipal Services the position will undertake a range of horticultural activities, specifically related to Alice Springs Town Council's (*Council*) playgrounds and open areas. Assist in the installation, maintenance and repairs of equipment in accordance with Australian standards, plus undertake general horticultural activities at Council parks, ovals and associated facilities

Key Responsibilities

- Assist in the installation, maintenance and repair work on Council equipment in line with Australian standards e.g. paving, security fencing, graffiti removal and laying of top covers (bark/mulch) etc.
- Undertake a range of horticultural activities particularly mowing, spraying, slashing, topdressing, scarifying, fertilising and aerating turfed areas.
- Carrying out emergency maintenance works, labouring duties and basic administrative and reporting procedures.
- Operate and maintain a broad range of plant and equipment to a safe and competent standard and identify any necessary repairs.
- Identify and remove weeds, pests and diseases and eradicate them through the use of pesticides and herbicides.
- Work as part of a team cooperating with supervisors to ensure activities related to safety, quality and environmental protection requirements are met.

Work Health & Safety (WHS) Responsibilities

- Take reasonable care for own health and safety.
- Take reasonable care to ensure team members actions or omissions do not adversely affect the health and safety of others.
